NOTICE TO CLIENTS

ELECTRONIC IMPORT DELIVERY ORDERS

APL is pleased to advise that we will soon be launching our Electronic Import Delivery Order (E-IDO) initiative. Using E-IDO, containers will be collected from the terminals using our uniquely generated PIN number identification, instead of the currently used system of presenting a paper delivery order. We hope this will save our clients considerable time and courier costs.

We shall be launching EIDO for cargoes into Fremantle. The first vessel will be the **Maersk Drammen 0811 ETA Fremantle on the 15th May 2008.**

For this and subsequent WBX and AAX vessels into Fremantle, subject to the normal clearance process being completed and payment being made, EIDO's will be emailed to the consignee showing on the bill of lading. Should you require release of the EIDO to a party other than that listed as the consignee on the bill of lading, a Letter of Authority will be required. Please contact your local APL Lines (Australia) office for a Letter of Authority format.

APL can only issue EIDO to **one email address**, so we recommend use of a group email to make sure that the EIDO is received by the correct department in your company. We also require confirmation that you have received the attached APL Electronic Delivery Order Terms and Conditions, understand them and agree to be bound by these Terms and Conditions. **Please note that this form must be signed by the consignee, not notify party.** Would appreciate if you could please fill out and return the below to your local APL Lines (Australia) office:-
